- ### RULES TO FOLLOW DURING USE OF JUMPER UNITS
- Adults supervision is absolutely required at all times.
 - If bouncy starts to deflate, all persons must exit jumper immediately!! Check for one the following conditions: 1. The motor has stopped; in which case check the cord connection that the outlet near thermotor and where the unit plugs into the house to make sure they have not come undone; 2. If motor continues to run, check for blockage of the air intake screen on the side of the blower unit. Also, check both air tubes on the back of the Jumper unit for snugness and tighten the ties if necessary; 3. If you cannot correct the problem call
 - ALL PERSONS MUST REMOVE SHOES before playing in jumper unit.
 - To avoid neck, back and other injuries; flipps, summer-salts and rough housing ARE NOT ALLOWED!!
 - Remove all eye glasses before entering the bounce jumper unit.
 - No sharp objects inside the jumper unit.
 - No food, drinks, candy, gum, or balloons inside the jumper unit.
 - No silly string on or inside the jumper unit.
 - Do not pull or hang on the netting.
 - Only compatible age groups and size shall play on the jumper unit at the same time.
The maximum number of riders of each group that should play in the jumper at one time are:
 - It is unsafe to stay in jumper unit if winds exceed 15 miles per hour. Please have all persons exit the jumper unit then unplug the blower unit and let the jumper deflate. If winds subside, plug blower unit back in and re-inflate jumper unit.
 - During periods of severed weather conditions (i.e. Rain, high, winds, etc) **AARON'S PARTY RENTALS** reserves the right to cancel your reservation.
 - Lessee agrees to keep the jumper unit in his/her custody and not to sublease, rent, sell or remove from the delivery address.
 - The lessee shall be in charge of the jumper unit's operation and is fully responsible for it's operation as well as for returning the jumper unit in good working order while in possession. The lessee, lessor and its officers, shareholders, directors, employees and agents are not responsible for injury occurring to the lessee or to any guest of lessee or to any other persons using the jumper unit while it is in the possession of the lessee. Lessee shall defend, indemnify and hold harmless lessor and its officer, shareholders, directors, employees and agents against and in respect of any and all claims, demands, losses, costs, expenses, obligations, liabilities, damages, recoveries, and deficiencies, including interest, penalties, and reasonable attorneys fees that lessor shall incur, or suffer, which arise, result from or relate to the use of the jumper unit by lessee, any guest of lessee, or to any other persons using the jumper unit or to a claim by any other persons injured by or on account of the jumper unit while the unit is in the possession of the lessee.
